Subject: **New Poll Results:** Harris Maintains 12-point Lead in Colorado

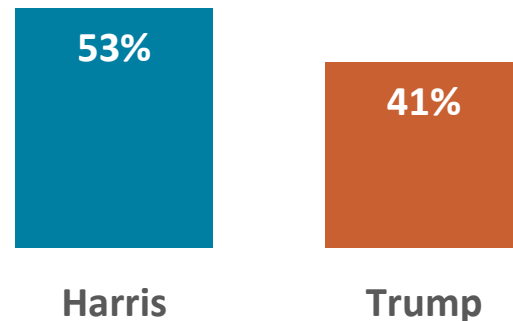
Kamala Harris is set to secure double-digit victory in Colorado.

In a new Keating Research poll of likely November 2024 voters statewide in Colorado, Vice President Kamala Harris leads Donald Trump by 12 points (**53% Harris, 41% Trump, 2% someone else, and 5% undecided**).

Harris' strong position heading into the final weekend of voting is due to a commanding 18-point lead with Unaffiliated voters (53% Harris, 35% Trump) and a decisive 29-point lead with women (61% Harris, 32% Trump).

Harris draws solid support across all age groups, with a strong 14-point lead with voters age 18-49 (53% Harris, 39% Trump) and a 9-point lead with those age 50 and older (52% Harris, 43% Trump).

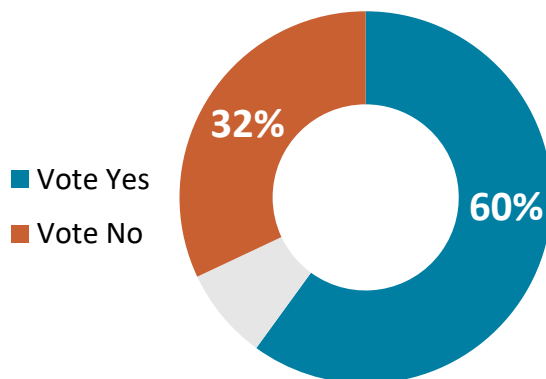
In the November 2024 election for President, will you vote for Democrat Kamala Harris or Republican Donald Trump?



Coloradans are poised to approve Amendment 79 to protect abortion rights.

Colorado voters are set to protect abortion rights in the state constitution, with Amendment 79 receiving 60% support from voters in this poll while 32% say they will vote no.

Support for Amendment 79 runs deep across demographic groups, including among two-thirds of women (67% voting yes) and a majority of men (54% voting yes), younger voters age 18-49 (63% voting yes) and older voters age 50+ (58% voting yes). Amendment 79 is supported by a 2-to-1 margin among Unaffiliated voters (63% yes, 27% no), while 9-of-10 Democrats (89%) and 1-of-4 Republicans (23%) are voting yes.



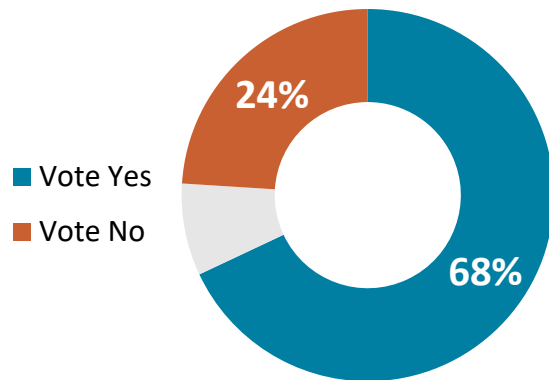
Shall there be a change to the Colorado constitution recognizing the right to abortion, and, in connection therewith, prohibiting the state and local governments from denying, impeding, or discriminating against the exercise of that right, allowing abortion to be a covered service under health insurance plans for Colorado state and local government employees and for enrollees in state and local governmental insurance programs?

Proposition JJ is on track to be approved with two-thirds support.

More than two-thirds of Colorado voters are backing Proposition JJ which would allow the state to retain all sports betting tax revenue to conserve and protect Colorado’s water.

Proposition JJ is supported by majorities in all parties, including 79% of Democrats, 69% of Unaffiliated voters, and 53% of Republicans. Across the state, strong majorities of voters in each region are voting yes, including 76% of voters in Denver / Boulder counties, 64% of voters in the five county Denver suburbs, 70% of voters in El Paso / Larimer / Pueblo / Weld counties, and 64% of voters in the 53 rural counties.

Without raising taxes, may the state keep and spend all sports betting tax revenue above voter-approved limits to fund water conservation and protection projects instead of refunding revenue to casinos?



These results are based on a hybrid poll of 600 likely November 2024 voters in Colorado, including 400 respondents contacted on the phone via live interviewers and 200 respondents invited via text message to complete a survey online. The sample is distributed to represent likely November 2024 voters in Colorado based on party registration, gender, age, ethnicity, region, and education. The worst-case margin of error at the 95% level is $\pm 4.0\%$. The poll was conducted from October 28 - 30, 2024, by Keating Research, Inc.
